**Cash bond or Surety Bond Attached.** The permittee shall deposit with the City no later than ten (10) days prior to the first day of conducting any carnival activity and shall maintain for a period of thirty (30) days after the termination of activities a cash bond of \$5,000, or in lieu thereof shall post and maintain in full force and effect during said period a surety bond in the amount of \$5,000. Such bond shall be issued by a surety company, approved by the City Attorney, and shall be in a form approved by the City Attorney.

**Proof from the Dept. of Safety and Professional Services.** The applicant must provide proof from the Department of Safety and Professional Services stating the carnival and rides are in compliance with all applicable State of Wisconsin rules and regulations prior to issuance of permit.

**Proof of insurance** in accordance with Wisconsin Administrative Code, Safety and Professional Services, Section 334.035 with an endorsement to the effect that the City will be indemnified and held harmless from any and all claims, damages or judgments arising from the granting of the permit or the operation of the show or exhibition.
